Motion to approve the expansion of the preschool disabled and multiple disabled program to include summer instruction beginning June 2013 as approved in the district budget. The program will be held 2.5 hours per day for the preschool disabled and 3.5 hours per day for the multiple disabled program, five days per week, for a total of five weeks. Staff will include appropriately certified classroom teachers (3), School Nurse, Speech Teacher and/or speech services through an outside consultant, and occupational and physical therapy through an outside consultant. It is also estimated to include the services of several classroom aides which may vary by enrollment. It is anticipated this in-house program will enhance services to the identified students in our district and may be open to other school districts for tuition students based on availability. Identified extraordinary services will be shared with the preschool disabled summer program when possible.
